STEP 2 IDENTIFY TRENDING/ HOT LEGAL TOPICS

WITH LEGAL NEWS

Use legal news to identify trending problems/issues disrupting your business and find newly released laws or cases, etc. Search by companies/industries, then narrow to legal topics.

Tools: LexisNexis Academic - All News - Advanced Options -U.S News; Wall Street Journal; New York Times etc.

STEP 4 UNDERSTAND THE RATIONALE BEHIND THE SCENE

WITH BOOKS AND LAW REVIEWS

Books and law reviews help with understanding the rationale behind the laws and cases with more scholarly discussion on controversial issues and their implications on your business. They help identify related cases and legislation.

Tools: LexisNexis Academic - Law Review; URSUS (Books)

STEP 6 SOURCE QUALITY ONLINE CONTENT

USING TARGETED GOOGLE SEARCH

Quality sources are often buried in overwhelmingly large amounts of outdated, misleading information online. Pay attention to the following:

Tools: laws and regulations from related government websites; trade associations website, reputable news sources, open-access law reviews.

STEP 8 DON'T FORGET TO CITE YOUR SOURCE

AND AVOID PLAGIARISM

Use quotations when you use exact words from a source. Use citations when you paraphrase or get an idea from a source. Close paraphrasing is plagiarism too.

SEARCHING IS A STRATEGIC EXPLORATION

STEP 1 FIGURE OUT DOMINANT LEGAL ISSUES FACING YOUR BUSINESS

BY ANALYSIS AND RESEARCH

Find legal issues by analyzing stakeholders (i.e. related government agencies, suppliers, competitors, consumers, employees), then researching what laws governing these relationships; or by finding a leading company and searching cases it is involved in.

Tools: IBISWorld; LexisNexis Academic - cases.

STEP 3 BACK UP YOUR LEGAL ANALYSIS

WITH REAL CASES

Cases will provide the background and court opinions. Use LexisNexis Shepard's to track and update cases. Search by parties (a leading company in your industry) or by business area/legal issues as keywords.

Tools: LexisNexis Academic - Federal & State Cases; Google Scholar (case law).

STEP 5 EVALUATE & UPDATE FACTS AND DETAILS

WITH CURRENT & AUTHORITATIVE INFO

Evaluate the information you gathered based on CRAAP Test (Currency, Relevance, Authority, Accuracy and Purpose). Shepardizing the cases and make sure it is not overridden.

STEP 7 SYNTHESIZE & RECONCILE DIFFERENCES

YOU ARE ALMOST THERE!

Synthesizing information and reconciling differences are the most challenging part of the analysis, while we are almost there!

STEP 2 IDENTIFY TRENDING/ HOT LEGAL TOPICS

WITH LEGAL NEWS

Tools: LexisNexis Academic - All News - Advanced Options -U.S News; Wall Street Journal; New York Times etc.

STEP 4 UNDERSTAND THE RATIONALE BEHIND THE SCENE

WITH BOOKS AND LAW REVIEWS

Books and law reviews help with understanding the rationale behind the laws and cases with more scholarly discussion on controversial issues and their implications on your business. They help identify related cases and legislation.

Tools: LexisNexis Academic - Law Review; URSUS (Books)

STEP 6 SOURCE QUALITY ONLINE CONTENT

USING TARGETED GOOGLE SEARCH

Quality sources are often buried in overwhelmingly large amounts of outdated, misleading information online. Pay attention to the following:

Tools: laws and regulations from related government websites; trade associations website, reputable news sources, open-access law reviews.

STEP 8 DON'T FORGET TO CITE YOUR SOURCE

AND AVOID PLAGIARISM

Use quotations when you use exact words from a source. Use citations when you paraphrase or get an idea from a source. Close paraphrasing is plagiarism too.

STEP 1 FIGURE OUT DOMINANT LEGAL ISSUES FACING YOUR BUSINESS

BY ANALYSIS AND RESEARCH

Find legal issues by analyzing stakeholders (i.e. related government agencies, suppliers, competitors, consumers, employees), then researching what laws governing these relationships; or by finding a leading company and searching cases it is involved in.

Tools: IBISWorld; LexisNexis Academic - cases.

STEP 3 BACK UP YOUR LEGAL ANALYSIS

WITH REAL CASES

Cases will provide the background and court opinions. Use LexisNexis Shepard's to track and update cases. Search by parties (a leading company in your industry) or by business area/legal issues as keywords.

Tools: LexisNexis Academic - Federal & State Cases; Google Scholar (case law).

STEP 5 EVALUATE & UPDATE FACTS AND DETAILS

WITH CURRENT & AUTHORITATIVE INFO

Evaluate the information you gathered based on CRAAP Test (Currency, Relevance, Authority, Accuracy and Purpose). Shepardizing the cases and make sure it is not overridden.

STEP 7 SYNTHESIZE & RECONCILE DIFFERENCES
